- SANCTION:** This meet is sanctioned by USA Swimming and Indiana Swimming. Sanction number IN10306.
- LOCATION:** Indian Creek Natatorium
Indian Creek High School
803 W. Indian Creek Drive
Trafalgar, IN 46181
- FACILITY:** The Indian Creek Natatorium has a 25-yard, 8 lane pool with 6 additional 20 yard lanes for continuous warm-up/cool down. Daktronics timing system and touchpads will be used with an 8-lane readout scoreboard. The competition course has not been certified in accordance with 104.2.2C(4). Pool depth at starting end is 5'0", and pool depth at turn end is 5'10".
- ELIGIBILITY:** Swimmers must be registered with USA Swimming to be accepted into this meet. Age as of May 22, 2010, will determine the swimmer's age for the meet.
- RULES:** Current USA Swimming and Indiana Swimming rule will govern this meet. **Start rule 102.14 & .4 & .5 will apply for this meet. The no recall starting procedure will be observed for all events in this meet.** Coaches MUST constantly display their USA Swimming coach credentials to gain deck access. The meet referee reserves the right to ask for coaches to display their credentials and/or deny deck access if a coach does not comply or card is no longer current.
- USA Swimming rule 202.3.2 states that a sanction competitive event, USA Swimming athletes members must be under the supervision of a USA Swimming coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in arranging for such supervision.
- In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in USA Swimming Rule 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.
- FORMAT:** This meet will be run on a timed final format in SCM.
- ENTRIES:** Swimmers are limited to four (4) events plus two (2) relays.
- Entries may be submitted by email, on computer disk, or in writing. Entry deadline is Saturday, May 8, 2010. Deadline will be extended if meet is not full. If submitting entries on computer disk or in writing, your entry fees and the signed release form should be sent with the entry. Teams that email entry must pay fees and submit signed release form by the start of the meet. A complete list of USA swimming registration numbers for all swimmers in the meet must be included with your entry. If it becomes necessary to limit events to establish a reasonable timeline, ICAC will refund entry fees to those clubs whose swimmers are not allowed to compete in the specific events.

FEEES: Entry fee is \$3.50 per individual event and \$5.00 per relay event as well as the \$1.50 Indiana Swimming surcharge per swimmer. Make checks payable to Indian Creek Aquatic Club. Deck entries will be \$5.00 per individual event and \$8 per relay event. Any entries after the entry deadline will be considered on deck and will be charged accordingly.

CHECK-IN: ALL SWIMMERS MUST CHECK-IN BEFORE WARM-UPS. Check-in sheets will be taken down 20 minutes after the start of warm-ups. Swimmer who fail to check-in will be scratched.

CLERK OF COURSE: This will be a card-less meet. 8 & Unders will be clerked and escorted to blocks.

AWARDS: No ribbons will be issued for this meet. All athletes will receive a t-shirt.

FINAL RESULTS: One copy will be provided to every participating club. Extra copies may be ordered for \$5.00.

PSYCH SHEETS: Pysch sheet swill be available for \$1.00. No admission charge.
