- SANCTION: This meet is sanctioned by USA Swimming and Indiana Swimming. Sanction number #IN10089
- LOCATION: Mooreville High School Swimming Pool
550 Indiana Street
Mooreville, Indiana 46158
- FACILITY: 25 yard, 8 lane course with 6 additional lanes for continuous warm-up/warm-down
Daktronics touch pads and timing system with an 8 lane readout scoreboard
- ELIGIBILITY: Swimmers must registered with USA Swimming to be accepted into this meet. Age as of 18 December 2009 shall determine the swimmers age for the entire meet. According to USA Swimming rule 202.3.2- at a sanctioned competitive event, USA swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm down.
- RULES: Current USA Swimming and Indiana Swimming rules will govern this meet. **Start rule 102.14 & . 4 &.5 will apply for this meet. The no recall starting procedure will be observed for all events in this meet. Coaches MUST constantly display their USA Swimming coach credential to gain deck access.**
The meet referee reserves the right to ask for coaches to display and or deny access if a coach does not comply.
EFFECTIVE (October 1, 2009) USA Swimming Suit Rule (102.9.1B)
In swimming competitions, the competitor must wear only one swim suit in one or two pieces expect as provided in 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.
- FORMAT: All events will be **TIMED FINALS**. The Meet Director reserves the right to limit entries in any event in order to adhere to the 4- hour rule for age group swimming. For swimmers not making cuts refunds will be made in events entered. Fastest seed time will be the determining factor. The number of heats will be determined after receipt of all entries and after reviewing the time line. **IF A SWIMMER SCRATCHES AN EVENT OR THE ENTIRE MEET, WE CANNOT SUBSTITUTE ANOTHER SWIMMER IN THEIR PLACE . THIS WILL BE CONSIDERED A NEW ENTRY AND WILL BE CHARGED ACCORDINGLY**
- USA Swimming Rules
202.3.2 At a sanctioned competitive event, USA swimming athlete members must be under the supervision of a USA Swimming member coach during warm up , competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.

ENTRIES: Swimmers are limited to four (4) events--- per day , except they can on in addition to the morning events enter the afternoon event 1650. Entries can be submitted by e-mail, on computer disk, or in writing. Fees and the signed release form for e- mailed entries must be received by **DECEMBER 05 AT 5PM.** Teams fees are expected to be paid with the team entry , teams are allowed to pay at the time of meet. Indicate if the swimmer is unattached. A complete list of USA swimming registration numbers for all swimmers entered in the meet must accompany your entry.

DEADLINE: **ENTRIES WILL BE ACCEPTED STARTING November 23, 2009 AT 8AM. ENTRY DEADLINE WILL BE DECEMBER 05,2009.** We will extend the deadline if the meet is not full.

FEES: Each event will be **\$4.00 per event.** Make checks payable to **MOORESVILLE HIGH SCHOOL SWIM TEAM.** INDIANA SWIMMING ATHLETE SURCHARGE OF \$1.50 COLLECTED. Fees for deck entries will be \$8.00. Entries made after December 08th will be considered on deck and charged accordingly. **Fees will be returned to teams with swimmers who do not make top 24 event list.**

CHECK-IN **ALL SWIMMERS MUST CHECK IN PRIOR TO WARMUPS.** Check in sheets will be taken down **15 minutes** after warm - ups begin. Swimmers who fail to check – in will be scratched. **There will be a separate check – in sheets for the, 1000, and 1650**

CLERK OF COURSE: No clerk of course

AWARDS: Ribbons 1-6 place will be awarded.

FINAL RESULTS: One copy will be provided to every participating club. Extra copies may be ordered for \$5.00
